## **Target Market Summary**

This product is likely to be appropriate for a consumer seeking capital growth over the long-term which may be used as a Solution/Standalone investment within a portfolio where the consumer has an investment timeframe of five years or more, a medium risk/return profile and needs daily access to capital.

# Description of Target Market

This part is required under section 994B(5)(b) of the Act.

The Fund aims to provide capital growth over the long-term by investing in undervalued companies in the Asian region excluding Japan.

The Fund seeks to provide annual distributions.

The Fund primarily invests in listed securities of Asian companies. Asian companies may list their securities on securities exchanges other than those in Asia and the Fund may invest in those securities. The Fund may invest in companies not listed in Asia but where their predominant business is conducted in Asia. The portfolio will ideally consist of 40 to 100 securities and cash may be held when undervalued securities cannot be found. The Fund can short sell securities that it considers overvalued. The portfolio will typically have 50% or more net equity exposure.

It is suitable as a Solution/Standalone investment within a client's portfolio.

The Fund is suitable for a client that is looking to invest in a fund with a minimum suggested time frame for investment of five years or more, but may be suitable for investment for shorter timeframes.

The Fund has a risk band of 4 (Medium).

The Fund primarily invests in listed equities traded on regulated exchanges. The Issuer generally maintains adequate cash levels in the Fund for the settlement of trades and to meet withdrawals made during the normal course of business.

#### Instructions

### Investment products and diversification

A consumer (or class of consumer) may intend to hold a product as part of a diversified portfolio (typically with an intended product use of *satellite/small allocation* or *core component*). In such circumstances, the product should be assessed against the consumer's attributes for the relevant portfolio, rather than the consumer's portfolio as a whole. For example, a consumer may seek to construct a conservative portfolio with a satellite/small allocation to growth assets. In this case, it may be likely that a product with a *High* or *Very High* risk/return profile is consistent with the consumer's objectives for that allocation notwithstanding that the risk/return profile of the consumer as a whole is *Low* or *Medium*. ## Consumer's Risk (ability to bear loss) and Return profile

Issuers should undertake a comprehensive risk assessment for each product. The FSC recommends adoption of the Standard Risk Measure (*SRM*) to calculate the likely number of negative annual returns over a 20 year period, using the guidance and methodology outlined in the <u>Standard Risk Measure</u> <u>Guidance Paper For Trustees</u>. SRM is not a complete assessment of risk and potential loss. For example, it does not detail important issues such as the potential size of a negative return or that a positive return could still be less than a consumer requires to meet their investment objectives/needs. Issuers may wish to supplement the SRM methodology by also considering other risk factors. For example, some products may use leverage, derivatives or short selling, may have liquidity or withdrawal limitations, or otherwise may have a complex structure or increased investment risks, which should be documented together with the SRM to substantiate the product risk rating.

A consumer's desired product return profile would generally take into account the impact of fees, costs and taxes.
