### TARGET MARKET SUMMARY

The Fund is designed for consumers who:

- are seeking capital growth and regular income
- are intending to use the Fund as a satellite within a portfolio
- have a medium to long-term investment timeframe
- have a high or very high risk/return profile, and
- require the ability to have daily access to capital.

- are seeking capital preservation, and
- are intending to use the Fund as a core component within a portfolio.

### Investment products and diversification
